Por medio de la presente se informa que, durante la descarga del buque MV MAERSK SEQUOIA 611N, con ETA 19 de marzo de 2026 a las 23:00 horas, correspondiente a la línea naviera MAERSK, 100 contenedores serán transmitidos del recinto de Terminal Multipropósito (OCUPA) al recinto de Terminal Especializada en Contenedores 1 (**SSA México**).
