Application Rules

1. **Delivery of Empty Container to Truck.-** This service consists of lifting the container using a yard crane or similar equipment provided by the service provider and placing it onto the applicant's trucking equipment.
2. **Receipt of Empty Dry Container with Basic Cleaning.-** This service consists of lifting the empty container from the trucking equipment, placing it in the designated area of the Off-Dock, and performing basic cleaning of the dry container, in accordance with established operational and safety conditions.
3. **Reception of Empty Refrigerated Container with Basic Cleaning.-** This service consists of lifting the empty refrigerated container from the trucking equipment, placing it in the assigned area of the Off-Dock, and performing basic internal cleaning, while verifying its general physical condition.
4. **Basic Cleaning of Dry Container.-** This service consists of performing basic interior and exterior washing of the container when it presents light dirt without solid or liquid residues. This service does not replace special cleaning procedures or cleaning required due to excessive residues.
5. **Special Cleaning of Dry Container.-** This service consists of cleaning containers that present residues that are difficult to remove, stains, grease, or adhered materials on the interior or exterior. It does not apply to infested containers or those requiring hazardous waste handling.
6. **Special Cleaning of Infested Empty Dry Container.-** This service consists of cleaning empty containers that show the presence of pests, strong odors, or biological contamination, including special disinfection treatment in compliance with established sanitary control protocols.

- 7. Cleaning of Empty Container Due to Excess Residues.-** This service applies when the empty container presents solid residues or remaining cargo materials. The level of residues will be determined by the operational area upon receipt. If the residue weight exceeds 50 kilograms, the service will be subject to a special quotation.

 - 7.1. Minimum Excess Residues.-** Applies to empty containers presenting solid residues or remnants in reduced quantities of up to 15 kilograms, requiring localized cleaning without the need for deep treatment.
 - 7.2. Medium Excess Residues.-** Applies to empty containers with moderate residues ranging from 16 to 25 kilograms, requiring more extensive interior cleaning with basic manual or mechanical removal.
 - 7.3. Moderate Excess Residues.-** Applies to empty containers with significant residues ranging from 26 to 35 kilograms, requiring deep washing and increased operational service time.
 - 7.4. High Excess Residues.-** Applies to empty containers with a high level of residues or material accumulation ranging from 36 to 50 kilograms, requiring intensive cleaning and proper disposal in accordance with waste handling procedures.
- 8. Service Call.-** This service consists of technical inspection or intervention performed on empty refrigerated containers, including electrical diagnostics, parameter verification, and minor adjustments, excluding major repairs or spare parts supply.
- 9. Interrogation Service for Empty Refrigerated Container.-** This service consists of parameter verification or data download performed on empty refrigerated containers outside the dock or main operating area, as requested by the customer.
- 10. Placement or Removal of Dangerous Goods Label per Container, per Label.-** This service consists of providing labor for the placement or removal of container labels. It is the responsibility of the Shipping Line, Customs Broker, or Authorized Customs Representative to deliver its container to SSA Marine Mexico facilities properly declared and correctly labeled in relation to the goods being transported, in accordance with Chapters 5.3 and 5.4 of the IMDG Code (Amendment 40-20).
- 11. Man-Hour.-** This service consists of assigning personnel at the customer's request to perform handling operations, supervision, or any extraordinary support related to empty container services. Time is calculated from the start to the effective completion of the service. A 50% surcharge will apply when the service relates to empty containers intended for refrigerated cargo.
